The student has skied/snowboarded/snowbladed (circle the appropriate sport). The student has received formal instruction, knows, and understands the Responsibility Code and can demonstrate ability at an advanced level. Such students can be called upon to assist in the program.

Warning:

As a result, lesson participation is encouraged but is not enforced. Students are then encouraged to remain on ski hills consistent with their level of ski.

I/we hereby release the DSBN and its staff and agents from any liability for any injury sustained regardless of how caused, resulting from participation in the Ski/Snowboard Club arranged through Centennial Secondary School on behalf of the DSBN. I/we further agree to indemnify and save harmless the DSBN and its staff and agents from any and all suits, demands, torts, and actions of any kind which may be brought against its staff or agents for which it/they may become liable by reason of any injury, loss, damage, or death resulting from, or occasioned to, or suffered by any person or any property, by reason of any act, neglect or default of time.

Blue Mountain has a Ski Patrol that will attend to students and minor injuries. They will assess the student and make recommendations for next steps.
